**Membership renewal is now due for the 2017-2018 Season!**



**You have from now until November 1, 2017 to get your membership renewal form and dues in to the club.**



**Memberships will be submitted by me 2X per month to the AWSC office due to a new transaction fee imposed by the AWSC office. This will save the club a tremendous amount by combining memberships for submission to the AWSC into 2 transactions per month.**

*(keep in mind, that processing times will be longer, so please plan ahead).*



**Membership packets with AWSC cards will be sent out to all members after November 1, 2017, after membership renewal period has passed.**

### Membership Renewal Reminders:

- ❖ **Seasonal Membership Renewal Dues shall be paid each year by November 1<sup>st</sup> of each season.**
- ❖ **All renewing members must renew and pay membership fee of \$25.00 between September 15<sup>th</sup> and November 1<sup>st</sup>.**
- ❖ **Renewals may be done by printing out and sending in the renewal form, or via the website on PayPal until November 1<sup>st</sup>.**
- ❖ **\*\*REMEMBER- Membership renewals submitted AFTER NOVEMBER 1<sup>ST</sup> of the season for renewing members will incur a \$10 late fee that shall be paid prior to processing the membership renewal.**
