- ❖ **Renewals may be submitted by printing out and sending in the renewal form off of our website, or via the PayPal link, available until November 1st.**

You may submit your completed forms and membership dues by bringing them to the meeting, or mailing to the PO Box on the membership form. You may also go to our website and renew with the PayPal link. Please remember that all renewal memberships must be submitted by November 1, 2019 deadline.

***NOTE:** Please remember that **this season's membership will END with the AWSC on June 30, 2020**, no matter what date you renewed your membership, per the new AWSC Membership Guidelines.

****IMPORTANT:** (This means that for the 2020/2021 season, each member will **HAVE TO renew** their membership with the AWSC **before** they will be able to order their trail passes.) Any order forms mailed in to the AWSC for trail passes will be returned to you if you have not renewed your membership prior to their receipt of your order. If ordering online, it will not allow you to order if your membership has not been renewed or processed prior to your trying to order trail passes. Please remember to allow 2 weeks processing time for your memberships, as there are fees for each membership submission, so we only submit every 2 weeks or so to the AWSC so as to defer as many of these processing fees as possible. The AWSC is also receiving \$2.00 more of each membership submitted to the club than in the past, so to keep our club membership fees the same, and not increase club dues, we will continue to combine membership submissions to the AWSC.
